

11/15-12/15 SPECIAL OPEN ENROLLMENT PERIOD (SOEP): JANUARY 2025 MID-ATLANTIC REGION

Carriers may not decline a small group (1–50), that submits between November 15th–December 15th, for failure to meet contribution and/or participation requirements. Groups that submit under the FOE window will be effective January 1st of the following year.

Groups must still qualify as an eligible small group and meet all other standard carrier requirements before they can qualify for FOE; only contribution and participation requirements are waived. When submitting be sure to clearly label your submission as an FOE Group on the Employer Application and/or in the subject line of your email.
