How to access online will preparation

1. Visit one.telushealth.com (username: MyEAP password: wellness).
 - Click on the **Life** tab in the top ribbon, then click on **Support & Resources**. Scroll down to **Quick Links**, click on **Legal Forms Generator** (this can be found halfway down the page)
2. Now that you are in the Legal Resource Center, click on **Personal Documents** and select your resident state.
 - Scroll down to find related documents in the sections titled, **Creating a Will**
 - Click on **Get Started** for information about the document, then click **Start Now**
3. You will be prompted to register; this is required to access legal documents and the My Document tool.
 - Click on **Register Now** and enter the required information, review the terms and click Register
4. A new tab will open, introducing **Rapidocs** with detailed, step-by-step "How to Use" instructions.
 - Rapidocs will ask a series of questions to assist in creating your legal document
 - Monitor your progress as you move through the questionnaire
5. **Out of time?** You can come back any time to finish or edit your legal document.
 - Documents are saved and accessible in the **My Documents** tool and can be exported in Word or PDF format
