

# Important Information: Oxford Liberty Network

Effective upon renewal, beginning with a September 1, 2022, policy effective date, the New York Oxford<sup>1</sup> Liberty Network will be paired with the UnitedHealthcare Core Network for national network access when members are outside the Oxford tri-state service area.<sup>2</sup>

UnitedHealthcare Core is a focused network of providers designed to achieve savings while still offering broad access to care. With almost 900,000 providers in the UnitedHealthcare Core Network,<sup>3</sup> employees and dependents traveling or living outside the tri-state service area can feel confident about having access to care. Plus, all Oxford plans include 24/7 Virtual Visits, virtual weight-loss and wellness coaching, and access to personal benefit advocates to help connect your employees to care—whenever, wherever.

**Local Access:** The **Oxford Liberty Network** provides access to care across the tri-state region (New York, New Jersey, Connecticut), with more than 119,000 providers.<sup>4</sup>

- New York physicians: 63,510
- New Jersey physicians: 32,857
- Connecticut physicians: 22,743



**National access:** Members enrolled in **Oxford Liberty Network** plans have additional access to our national UnitedHealthcare Core Network<sup>3</sup> when traveling outside the Oxford tri-state service area.<sup>2</sup>

- Physicians and health care professionals: 895,806
- Hospitals: 5,001



**Pharmacy:** Convenient access to approximately 50,000 retail pharmacies nationwide,\* including major chains, mass merchants and supermarkets
